The bedrooms are believed to have hardwood flooring under the wall-to-wall carpet. The ample living room has sliders to the rear patio and flat, fenced yard for alfresco dining, exercising pets or kicking a ball around. The lower level has a finished family room, as well as an unfinished laundry/utility/storage room. There is parking for up to three cars via the carport and driveway. It would be relatively easy to create an electric car charging area in the carport because the electrical panel is nearby and it has room for additional breakers.
